Todd Benzinger returns for his second season as manager of the Dragons. He was the first baseman on the Reds 1990 World Series championship club and recorded the final out of the series when he caught a foul pop off the bat of Oakland's Carney Lansford in the ninth inning of game four. He spent nine years as a player in the major leagues with the Reds, Red Sox, Royals, Dodgers, and Giants, playing in 924 major league games. Benzinger, 45, is a Cincinnati-area native. He was an All-American at New Richmond (Ohio) High School and now resides in West Chester. He has enjoyed a highly-successful career coaching girls' high school basketball in the Cincinnati area since 1999.
